Learn about identification, biology, ecology, control, and regulations for management of aquatic weeds

The Aquatic Weed School 2018 is an intensive **two-day course** focusing on issues associated with developing weed management strategies in a variety of aquatic ecosystems. The course provides a rare opportunity for professionals to efficiently update their understanding of aquatic weeds and interact with experts in this field.

WHO SHOULD ATTEND

The Aquatic Weed School is designed for those involved in consulting, research, and management of aquatic weed systems throughout the western United States.

TOPICS include:

ecological classification and impacts of aquatic weeds ■ biology of aquatic weeds ■ physical and chemical characteristics of aquatic ecosystems ■ regulatory issues—update on National Pollutant Discharge Elimination System (NPDES), are herbicides safe, label compliance and CA herbicide registration ■ adjuvants and surfactants for aquatic systems ■ aquatic weed ID ■ personal protective equipment ■ developing an IPM plan ■ pest prevention for aquatic weeds ■ physical and mechanical control methods ■ biological control ■ chemical and non-chemical control ■ integrated and adaptive aquatic plant management program

These topics are presented in lecture, laboratory and demonstration formats. Each attendee will receive a comprehensive course notebook with lecture notes and additional information.

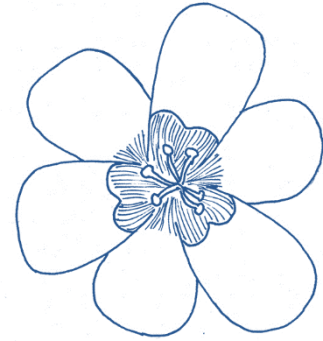

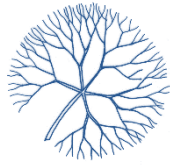
