Learn about identification, biology, ecology, control and environmental impacts of managing weeds

The Weed Science School is an intensive **2-1/2 day course** focusing on the mode and mechanism of herbicide activity in plants and the fate of herbicides in the environment. This course provides a rare opportunity for professionals to efficiently update their understanding of weed science and the action of herbicides in the plant and the environment. Emphasis is on herbicides registered for use in California and important weeds within the state. Weed science professionals will appreciate the latest research provided by some of the most respected weed scientists in the world.

WHO SHOULD ATTEND

The Weed Science School is designed for those involved in consulting, research, development, or sales of agricultural chemicals in either the private or public sector.

TOPICS include:

general plant biology ■ weed ecology: competition ■ herbicide absorption, translocation and metabolism ■ lipid and amino acid synthesis inhibitors ■ cell division and cell wall inhibitors ■ photosynthetic and pigment synthesis inhibitors and free radical generators ■ growth regulators ■ herbicide degradation and physical removal in soil ■ ground and surface water contaminations and regulatory aspects ■ herbicide resistance and tolerance mechanisms ■ physical control and other organic weed management strategies ■ weed management and wildlands ■ weed seed biology ■ herbicide drift and the utility of a symptomology website ■ what's new in application technology ■ weed ID ■ spray nozzles ■ adjuvants ■ herbicide symptomology lab

These topics are presented in lecture, laboratory and demonstration formats. Each attendee will receive a comprehensive course notebook with lecture notes.
